(A meeting with a planning consultant is scheduled 10/5.) A Historical Resource Reconnaissance/ watershed wide is beyond the scope of this committee, but a more specifically sited reconnaissance is being investigated where no historic data is available.

Outreach subcommittee update: have produced factsheets a banner and photo loop. The will be taking a look at needs at their upcoming meeting.
